Items 78150, 78154, 78165, 78167, 78168, 78170, 78171, 78173, 78174, 78179, 78181, 78185, 78189 consist of statements of individuals who are not witnesses in this case, and provide contextual or incriminating information relating to incidents that are not charged in the Indictment. The information contained in some of these documents is also reflected in already disclosed documents (see, for example, 78185 reflected in U000-2059-U000-2061). Nine documents relate primarily to investigations pertaining to matters already disclosed through other documents containing similar information (See 78175 reflected in SITF00141873-00141875; 78157 reflected in SITF00085494-00085499; 78148 reflected in SPOE00125851-00125886; 78172 reflected in SITF00306542-00306542, SITF00300099-00300101, SITF00300095-00300096; 78158 reflected in SITF00337038-00337040, SITF00322963-00322965, SITF00322966-00322968 and SITF00322928-00322928; 78169 reflected in SITF00322697-00322697; 78161 reflected in SITF00322830-00322851; 78151 reflected in SPOE00162923-00162924, SPOE00162815-00162816; and 78159 reflected in SITF00408096-00408101).
