#### I. INTRODUCTION

 Pursuant to the Trial Panel's "Decision on the submission and admissibility of non-oral evidence" and Rule 138(1) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), the Defence for Mr Pjetër Shala ("Defence") hereby files this request seeking the admission into evidence of material used during its direct examination and re-examination of witnesses Zijadin Hoxha (W03887), Andre De Villiers Horne (DW4-03), and [REDACTED] (W04280), during their in-court testimony, including material shown to and marked by the witnesses.<sup>1</sup>

#### II. PROCEDURAL BACKGROUND

- 2. On 17 March 2023, the Panel issued the "Decision on the submission and admissibility of non-oral evidence", in which it, *inter alia*, set out the principles governing the admission of non-oral evidence and ordered the Parties and Victims' Counsel to submit, no later than one week after the completion of each evidentiary block, an application for the admission of any material used during their respective questioning of the witnesses whose testimonies were completed within that block and which had not already been submitted to the Panel.<sup>2</sup>
- Between 20 to 22 November 2023, W03887 testified via video-conference before the Panel during the tenth evidentiary block.<sup>3</sup>


