## PROCEDURAL HISTORY

- 1. On 8 March 2023, the Specialist Prosecutor's Office ("Prosecution") filed a motion seeking the admission the Accused's prior statements.<sup>1</sup>
- 2. On 25 April 2023, following an extension of the time-limit,<sup>2</sup> the Defence filed its response.<sup>3</sup> The Prosecution replied on 10 May 2023.<sup>4</sup>
- 3. On 9 November 2023, the Trial Panel issued the Impugned Decision.<sup>5</sup>
- 4. On 27 November 2023, the Defence filed a request for certification to appeal the Impugned Decision.<sup>6</sup> On 7 December 2023, the Prosecution responded to the Defence request.<sup>7</sup> On 15 December 2023, the Defence replied to the Prosecution Response.<sup>8</sup>

- 5. On 19 December 2023, the Trial Panel issued its Decision on Defence Requests for Certification to Appeal the Decision on Prosecution Motion for Admission of Accused's Statements.<sup>9</sup>
- 6. On 21 December 2023, the President of the Specialist Chambers assigned a Court of Appeals Panel to determine the appeal of the Impugned Decision.<sup>10</sup>
- 7. On 22 December 2023, following a Defence request for extension of time,<sup>11</sup> the Court of Appeals Panel extended the time limit to file the appeal to 12 January 2024.<sup>12</sup>
