I. INTRODUCTION

1. Pursuant to the Trial Panel's "Decision on Defence requests for admission of evidence (F00770/COR and F00771) and on evidence called by the Panel" and Rules 119(2) and 119(5) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), 1 the Defence for Mr Pjetër Shala ("Defence") hereby files its amended Witness List, Witness Summaries, and Exhibit List, which are attached as Annexes I, II, and III, respectively.

II. PROCEDURAL BACKGROUND

- 2. On 17 March 2023, the Panel issued the "Decision on the submission and admissibility of non-oral evidence", setting the principles which govern the admission of non-oral evidence in the case.²
- 3. On 15 January 2024, the Defence requested to admit into evidence the written statements of [REDACTED], pursuant to Rule 155 of the Rules and to amend its Witness and Exhibit Lists to add him as a witness and his statement as exhibits.³

5. On 18 January 2024, the Prosecution filed a consolidated response to the

Defence First and Second Requests.⁵

6. On 24 January 2024, the Panel: i) granted the Defence First Request; and ii)

granted the Defence Second Request in relation to items 4-10 and rejected the

remainder of the Defence Second Request.⁶ In addition, the Panel ordered the

Defence to file its amended lists of witnesses and exhibits accordingly by 26

January 2024.⁷

III. SUBMISSIONS

7. The Defence submits its amended Witness List, Witness Summaries, and

Exhibit List, which are presented as an attachment to this filing as Annexes I,

II, and III, respectively, adding [REDACTED] as a witness and his statements

and items 4-10 listed in the Defence Second Request as exhibits.8

8. In addition, the Defence hereby notifies the Panel, the Registry, the Parties, and

participants that the witness code attributed to [REDACTED] is DW4-09.


