TRIAL PANEL II ("Panel"), pursuant to Articles 21(2), 23 and 40(6)(f) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office ("Law") and Rules 80, 84(1) and 116(4)(b) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), hereby renders this decision.

I. PROCEDURAL BACKGROUND AND SUBMISSIONS

- 1. On 6 to 8 November 2023, W03825 testified in the present proceedings.¹
- 2. On 7 November 2023, the Panel issued an oral order on the review of private session portions of hearing transcripts in view of their reclassification, wherein it set out the procedure to be followed by the Parties and participants.²
- 3. On 8 November 2023, the Panel issued a number of post-session redactions orders to the transcript of the same day.³
- 4. On 18 December 2023, the Specialist Prosecutor's Office ("SPO") filed submissions ("SPO Submissions") in relation to W03825's testimony transcript of 6 to 8 November 2023 ("W03825's Transcript"), to which it annexed a consolidated proposal of a public lesser redacted version of said transcript ("Annex 1").⁴ According to the SPO, the proposed redactions are necessary: (i) to give effect to special measures ordered by the Panel; (ii) to protect information which would reveal the content of documents with Rule 107 restrictions; (iii) to protect sensitive information about the witness's health, dignity and family members; and (iv) to protect other witnesses with protective measures.⁵ Victims' Counsel agrees with

the redactions proposed by the SPO.6 According to the Witness Protection and

Support Office ("WPSO"), a further sixty-six redactions are necessary for reasons

similar to those advanced by the SPO.7 The Thaçi Defence objects to seven of the

proposed redactions as they do not identify witnesses with protective measures,

or information subject to Rule 107 restrictions.8 The other Defence teams did not

respond inter partes.9

II. **DISCUSSION**

5. The Panel recalls that, while W03825 has not been granted in-court protective

measures, the Panel approved a special measure for W03825, namely that

[REDACTED].¹⁰

The Panel also recalls that it previously authorised redactions to the transcript of

8 November 2023 as it contained confidential information.¹¹ The redaction authorised

in one of these orders is not reflected in Annex 1 and accordingly the Panel

incorporates this redaction in this decision and orders that it be redacted.¹²

7. Further to the Parties' and participants' submissions, 13 the Panel considers that,

except for the redactions specified below, the redactions proposed in Annex 1 remain

necessary and proportionate and consistent with the effective protection of the rights

of the Accused.

The Panel considers that for reasons of consistency with other proposed redactions that are necessary and proportionate to prevent identification of sensitive information linked to W03825 and W03825's family by the public:¹⁵ (i) page 9387, lines 6 to 7,¹⁶ page 9450, line 24,¹⁷ page 9485, lines 14-15,¹⁸ page 9583, lines 9-10¹⁹ and page 9588, lines 7-9 and 12-13;²⁰ and (ii) the references to "[REDACTED]" on page 9363, line 14, page 9386, lines 20-21, page 9554, lines 9, 11, page 9600, line 23, and page 9632, lines 16-17 should also be redacted.

10. In the interest of guaranteeing to the greatest possible extent the publicity of the proceedings, the Panel orders that the remainder of W03825's Transcript be

reclassified as public.

III. DISPOSITION

11. For the above-mentioned reasons, the Panel hereby:

FINDS that, except for the redactions specified in paragraph 6 and 9, a)

those portions of W03825's Transcript identified in Annex 1 are suitable for

reclassification, and that those redactions identified in paragraph 8 above

are suitable for reclassification, and can be reclassified as public;

b) **APPROVES** the proposed redactions as set out in Annex 1, subject to the

changes specified in paragraphs 6, 8-9 above; and

c) **DIRECTS** the SPO to communicate to the Registry a public lesser

redacted version of W03825's Transcript in accordance with the

redactions approved in the present decision.
