I. INTRODUCTION

1. Pursuant to Article 22(3) and (6) of the Law on Specialist Chambers and

Specialist Prosecutor's Office (Law No. 05/L-053) ("Law"), and Rule 114(4)(a) of

the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers

("Rules"), Victims' Counsel requests permission to provide five statements

which were made by [REDACTED] (deceased) to [REDACTED], V268/06,

V269/06, and V270/06 ("the VPPs"), at their request. These statements are

currently classified as confidential.

2. These statements are contained in [REDACTED] in two documents: (i)

[REDACTED] and (ii) [REDACTED]. [REDACTED] contains [REDACTED] of

[REDACTED]'s statements, admitted [REDACTED] as [REDACTED].1

[REDACTED] is the [REDACTED], and admitted [REDACTED] as

[REDACTED].²

II. CLASSIFICATION

3. This submission is classified as strictly confidential and *ex parte* pursuant to Rule

82(1) and (3). The information contained herein, despite the use of pseudonyms,

would clearly identify the concerned single-status VPPs when connected with

the statements of [REDACTED]. A redacted strictly confidential ex parte Defence

only version is filed simultaneously.

III. BACKGROUND

4. V268/06, V269/06, and V270/06 were admitted as victims participating in the

proceedings ("VPPs") on 15 February 2023.3 [REDACTED] is deceased4 and is

not subject to protective measures. [REDACTED]'s statements were admitted

pursuant to Rules 138(1) and 155 as exhibits in Case 06 and are classified as

confidential.5

5. [REDACTED] have asked to be provided with [REDACTED] statements in order

to have what happened to [REDACTED], [REDACTED], and [REDACTED], "in

[REDACTED] own words". The VPPs concerned were [REDACTED] at the time

of events that changed their lives irreversibly. Their wish is to keep a tangible

memory of what happened to [REDACTED], [REDACTED], and [REDACTED]

as described by [REDACTED].

6. Following a request by Victims' Counsel, the SPO indicated by email on 13

November 2023 that they would "support any application to the Panel for

authorisation to share these confidential, admitted exhibits with the witness's

[REDACTED]."6 On 16 November, the SPO further indicated to Victims'

Counsel that they did not oppose [REDACTED] from receiving [REDACTED]

the statement in due course.⁷

IV. SUBMISSIONS

8. Victims' Counsel notes that paragraph 212(I) of the Framework Decision for the

Handling of Confidential Information does not regulate this specific instance.9

Neither do the Rules.¹⁰ Therefore, a request for leave to provide the identified

documents to the three VPPs is necessary.

[REDACTED] is deceased and the SPO has consented to the provision of the two identified documents to [REDACTED]. Should the Panel grant the request, Victims' Counsel will instruct the concerned VPPs that the statements

they are receiving are confidential and that they must not be shared with others.
