As per order R001/F00007 in KSC-CA-2023-02, this filing is cross-filed KSC-BC-2020-05/R001/F00007/2 of 3

- 1. First, the Registrar notes that Ms Venkateswari Alagendra ('Ms Alagendra') has been and continues to be appointed as Counsel for Mr Jakup Krasniqi in Case KSC-BC-2020-06.¹
- 2. On 11 January 2024, the Registrar notified the President of the Specialist Chambers ('President') of the approval, on 3 January 2024, of Ms Alagendra as Counsel for Mr Salih Mustafa ('Mr Mustafa').²
- 3. On 15 January 2024, Mr Mustafa filed a request before the President for an extension of the time limit for requesting protection of legality in relation to the final judgment in his case.³
- 4. On 17 January 2024, the President assigned a Single Judge, Judge Gilbert Bitti, to oversee the implementation by the Registrar of the Reparation Order against Mr Mustafa.⁴
- 5. On 22 January 2024, Counsel for Mr Mustafa, Ms Alagendra, submitted a request before the Single Judge for a temporary stay of setting a time limit for payment of reparations.⁵
- 6. On 23 January 2024, the Specialist Prosecutor's Office ('SPO') challenged the appointment of Ms Alagendra before the Supreme Court Panel, due to a potential conflict of interest ('Motion').⁶
- 7. On 25 January 2024, the Supreme Court Panel ruled on the SPO's request, declaring that the Registrar's decision in relation of the appointment of Ms Alagendra
