1. Pursuant to the Decision of Trial Panel II,¹ the Registrar hereby provides submissions on the reclassification of filings in the case file.

- 2. The Registrar has no objection to the reclassification of the following as public:
 - a. F02068 (main filing only), 19 January 2024, current classified as confidential;
 - b. F02079 (main filing only), 26 January 2024, current classified as confidential;
 - c. F02088 (main filing only), 29 January 2024, current classified as confidential and *ex parte*; and
 - d. F02093 (main filing only), 31 January 2024, current classified as confidential and *ex parte*.
