Pursuant to the Pre-Trial Judge's Order,¹ the Specialist Prosecutor's Office ('SPO')

makes the following proposal regarding the copying and transfer of files. As the Pre-Trial

Judge is aware, the SPO has filed a request to join KSC-BC-2023-10 ('Case 10') and KSC-

BC-2023-11 ('Case 11').² Should the Pre-Trial Judge grant the joinder request, the SPO

proposes that the items filed in both Cases 10 and 11 be consolidated.

Should it be necessary to copy and transfer files while the joinder request is pending,

the SPO submits that all filings and decisions from KSC-BC-2018-01 that were previously

transferred to Case 10 be copied and transferred to Case 11 (these should however retain

their original classifications pending review for reclassification and further or lesser

redaction).

In addition, the SPO has identified several further items in KSC-BC-2018-01 which

should now be copied and transferred to both Cases 10 and 11:

i. F00474;

F00513; and ii.

F00521 with Annex 1. iii.

Specifically, the SPO proposes that (i) F00474 retain its classification for the same

reasons as set out in Case 10 filing F00090³ and be transferred to both Cases 10 and 11;
