- 1. The Defence for Mr. Haxhi Shala ("Accused") hereby joins the Challenge to A7 Redaction pursuant to Paragraph 102 of the Framework Decision on Disclosure of Evidence and Related Matters<sup>1</sup> which the Sabit Januzi Defence filed confidentially on 6 March 2024 ("Sabit Januzi Challenge"). It concerns redactions [REDACTED] ("Impugned Redactions") which the Specialist Prosecutor's Office ("SPO") disclosed on 15 December 2023 as part of Disclosure 6 in SPO v. Sabit Januzi and Ismet Bahtijari.<sup>2</sup> The SPO made the redactions pursuant to the Framework Decision on Disclosure of Evidence and Related Matters in SPO v. Sabit Januzi and Ismet Bahtijari.<sup>3</sup>
- On 19 January 2024 the SPO disclosed in Disclosure 5 in SPO v. Haxhi Shala the same document subject to the same redactions pursuant to Framework Decision on Disclosure of Evidence and Related Matters<sup>4</sup> which the Pre-Trial Judge issued on 19 December 2023.
- 3. On 8 February 2024 in the Decision on Request for Joinder and Amendment of the Indictment<sup>5</sup> ("Joinder Decision"), the Pre-Trial Judge granted the

joinder of SPO v. Sabit Januzi and Ismet Bahtijari and SPO v. Haxhi Shala but determined that separate indictments should remain operative.<sup>6</sup>

 The Haxhi Shala Defence adopts Sabit Januzi's reasons for challenging the Impugned Redactions<sup>7</sup> and the conclusions drawn from them.<sup>8</sup>
