We will start hearing the evidence of Thaci witness 1DW-008. 12 Before we start hearing the evidence of the witness, there is a 13 14 preliminary matter that the Panel would like to address. The Panel notes in filing F03569 the Thaci Defence requested, 15 first of all, an expedited briefing schedule for the filing; and, 16 second, leave to amend its exhibit list to add one item that it 17 intends to use with 1DW-008. 18 The SPO responded that it does not object to the request. 19 First, the Panel notes that the expedited briefing schedule for 20 the request on Friday, 7 -- I'm sorry, I said that wrong. First, the 21 Panel notes that it expedited the briefing schedule for the request 22 on Friday, November 7th, 2025. 23 Second, in respect of the Thaci Defence request to add a video 24

of the press conference by 1DW-008 and its corresponding transcript

to the exhibit list, the Panel notes that, one, the video was

disclosed on 16 October 2025; and, two, the Thaci Defence was only

- able to assess the full evidentiary need of the video in the
- 4 preparation session it held with 1DW-008 on the evening of
- 5 November 2025. The Panel recalls that the relevance and importance
- of certain items may become apparent to a party as the trial
- 7 proceeds. In addition, the Panel notes that the Thaci Defence made
- 8 the request two days after it realised the importance of the item.
- 9 The Panel therefore finds that the Thaci Defence has provided timely
- 10 notice.
- The Panel observes that the document relates to the witness's
- interactions with the KLA and his observations on the level of
- organisation and command and control of the KLA in 1998. These are
- topics relevant to the charges in the indictment. The Panel
- therefore finds that the material is prima facie relevant and of
- sufficient importance, and that there is good cause for its late
- 17 addition to the exhibit list.
- Lastly, regarding prejudice, the Panel observes that the request
- is limited in scope as the Thaci Defence only intends to use one
- 20 minute of the video. The Panel further notes that the SPO does not
- object to the addition to the exhibit list. Given that the parties
- and participants will have sufficient time to adequately review the
- video and prepare for 1DW-008's testimony, the Panel finds that no
- 24 prejudice will arise from adding the video and its transcript to the
- exhibit list.

- 4 A. My name is Christopher Robert Hill.
- 5 Q. And what is your date of birth?
- 6 A. 8/10/52. That is August 10th, 1952.
- 7 Q. And what is your nationality?
- 8 A. I'm a US citizen.
- 9 Q. And is it correct that you are a retired United States diplomat?
- 10 A. That is correct.
- 11 Q. And your title at the time of your retirement is ambassador?
- 12 A. Correct.
- Q. Yes. Can you tell us a little bit about your background? What
- degrees have you achieved?
- 15 A. Sure. I majored in economics in college and graduated from
- 16 Bowdoin College. I also received a master's from the Naval War
- 17 College some years later while I was in the State Department. Do you
- 18 want me to discuss my career in the State Department --
- 19 Q. We'll --
- 20 A. Okay.
- Q. I think I've already started to speak too fast, so I will take a
- pause for a second. We will get to your diplomatic career in a

- at the Naval War College. Can you tell us what the degree was in? 1
- National security studies. 2
- Okay. And did your master's degree provide you any familiarity 3
- with military structures and organisations?
- Yes, it did. 5
- Okay. When did you start your diplomatic career? Q. 6
- 7 I started my diplomatic career -- I entered the foreign service
- in October 1977. 8
- And can you tell us what your postings were in your diplomatic 9
- career prior to 1998? 10
- Prior to 1998, I entered the service in October 1977. My first 11
- assignment was in Belgrade, Yugoslavia, in summer of 1978. I was 12
- there until the summer of 1980. I returned to the State Department 13
- 14 in 1980, and I was a watch officer in the State Department, and then
- a member of the policy planning staff until I went to Warsaw, Poland, 15
- in 1983. I departed Warsaw in 1985 and went to Seoul, Korea, in 1985 16
- until 1988. At that time, I returned to the States. I worked for a 17
- 18 congressman on a fellowship within the framework of the
- State Department from 1988 to 1989. And in 1989, I was the -- I 19
- became the desk officer for Poland. 20
- And in 1991, my next assignment was I went to Albania, Tirana, 21
- Albania, where I opened the American embassy which had been closed 22
- since 1946. I departed Tirana, Albania, in 1994, and at that time 23
- became the director for the Balkans office in the State Department, 24
- 25 culminating in my participation in the Dayton peace talks which was

in October until November 1995.

- 2 After that, I went to Republic of North Macedonia in summer
- 3 1996. And in 1998, while I was still in the Republic of

- issues and completed those assignments in the summer of 1999.
- 6 Q. Thank you. Just to follow up on that. In your postings in
- 7 Tirana and North Macedonia, did you have any opportunity to either
- 8 travel to Kosovo or to become familiar with the issues in Kosovo?
- 9 A. Kosovo was a major issue within the Balkans but, at that time,
- not the number one issue, which, of course, was the wars that had
- gotten underway including in Bosnia and between Serbia and Croatia.
- Nonetheless, while in Albania, during those two years in Albania, I
- learned a lot about the Kosovo situation. I did not actually visit
- 14 Kosovo until May 1998 when I was asked to take it on as an additional
- responsibility to my responsibilities as the US ambassador to Skopje.
- Q. Thank you. Did you return to the United States in 1999; and if
- so, what positions did you hold in 1999 and 2000?
- 18 A. I returned to the United States in 1999, summer of 1999. And in
- 19 September 1999, I became the senior director at the National Security
- 20 Council staff, senior director for south-eastern European affairs,
- 21 namely, the Balkans. I did that -- I performed those duties until
- the summer of 2000 at which point I went to Warsaw, Poland, as the US
- ambassador.
- Q. Okay. As part of your duties on the National Security Council
- staff, was Kosovo part of your portfolio?

- 1 A. Yes, it was.
- Q. What languages do you speak?
- A. Well, it's a function of what point in time, but I've spoken
- 4 Polish at a conversational -- better than a conversational level,
- 5 Serbian, and some -- I can speak some Albanian.
- 6 Q. Thank you. Now, you mentioned that you were involved in the
- 7 Dayton peace talks. Did you work with Ambassador Richard Holbrooke
- 8 at that time?
- 9 A. Every day.
- 10 Q. And was Kosovo an issue at the time of the Dayton talks?
- 11 A. The Dayton talks were very much focused on ending the war in
- Bosnia. However, the issue of Kosovo had come up in some
- circumstances where there were American citizens of Kosovo background
- who wanted us very much to take on the issue of Kosovo, but the focus
- continued to be on the crisis in Bosnia and that was what the Dayton
- peace accords were about.
- 17 We, of course, did have conversations about Kosovo. I had some
- direct conversations with President Milosevic in the context of the
- Dayton peace accords because we knew that Kosovo would be the next
- 20 crisis.
- Q. You just mentioned President Milosevic. At the time, meaning
- around the Dayton Accords and prior, had you had an opportunity to
- meet with the relevant officials or persons in the Balkans?
- 24 A. With respect to Kosovo?
- Q. Kosovo, Bosnia, Croatia, Serbia?

- Well, during the Dayton peace accords, of course, we had the 1
- president of Croatia, the president of Serbia, we had the senior 2
- officials including the president of Bosnia, so I spoke with those 3
- people on a daily basis. There were no representatives there from 4
- Kosovo or Albania. 5
- But prior to starting the Dayton peace talks, I did go and visit 6
- 7 Macedonia in the context of trying to address some of the issues that
- Macedonia had. 8
- I did not have an occasion to engage with Kosovo leadership. I 9
- will say, though, that going back to -- in 1989, I did have the 10
- occasion to meet Mr. Rugova at the American ambassador's residence, 11
- that is, Ambassador Zimmermann's residence. So that was my first 12
- conversation with Ibrahim Rugova. And so I met him subsequently in 13
- 14 1998, in May 1998.
- And just finishing up on your background, you've mentioned that 15
- you became the -- you were posted to Poland in 2000. Following your 16
- posting in Poland, what were your remaining postings in your career? 17
- Okay. After Poland -- I left Poland in 2004, and at that point 18
- I went to Korea as ambassador. I had been there earlier, as I 19
- mentioned, from 1985 to 1988, so I went back to Korea in 2004 20
- immediately after Poland. 21
- However, the Secretary of State, Condoleezza Rice, asked me to 22
- conclude my assignment in Korea and become the assistant secretary 23
- for Asia Pacific, which I started in the spring of 2005. At that 24
- time, they also asked me to take on the responsibility of heading the 25

- US delegation to the North Korean talks, which I did for some four 1
- years, from 2005 until 2009. 2
- In 2009, the incoming administration of President Obama, they 3
- asked me to go to Baghdad and become the US ambassador to Iraq, which
- I did in 2009. And I retired from the Foreign Service in 2010, went 5
- into academia, and then went back into the Foreign Service in 2022 as 6
- the US ambassador to Serbia. I stayed in that position until January 7
- of this year, 2025. 8
- Thank you. In these experiences in your diplomatic career, Q. 9
- would you regularly meet with heads of state? 10
- Oh, yes, I did. 11 Α.
- Would you meet with government ministers? Q. 12
- All the time. Α. 13
- 14 Q. Would you meet with military officials?
- Yes, many. 15 Α.
- Would you meet with foreign intelligence officials? Q. 16
- Α. Of course, yes. 17
- Non-state actors, would you meet with non-state actors? 18
- You mean such as business people and -- people like that, people 19
- who are not in the -- not in foreign governments? Yes, I would. 20
- Yes. As a diplomat, was it your job to assess the roles and 21
- authorities of persons with whom you interacted? 22
- All the time. That was my main job, to understand situations, 23
- to listen carefully, to understand power relationships, whether 24

- Q. And you mentioned you were in academia. Can you tell us what
- posts you've held in academia?
- 4 A. In academia, I became dean of the International School at the
- 5 University of Denver. Then I -- I did that for some eight years at
- 6 which point I was an adviser to the chancellor at the University of
- 7 Denver. After that, I went and taught at Columbia University for a
- 8 semester. And after that, I rejoined the Foreign Service as
- 9 ambassador to Serbia.
- 10 Q. And do you hold any posts in academia today?
- 11 A. Yes, I'm a professor of practice at Fletcher School, school of
- international law at Tufts University.
- 13 Q. Thank you.
- 14 A. If I could just say, Fletcher School's international --
- 15 diplomacy and international law.
- 16 Q. Thank you. Turning to your first engagement on the issue of
- 17 Kosovo. When were you first engaged by the United States Government
- in trying to resolve tensions in Kosovo?
- 19 A. I was first engaged by the US Government in May 1998.
- 20 Q. And who asked you to get involved in that issue?
- 21 A. I had a telephone call from then Secretary of State
- Madeleine Albright, and she asked me if in addition to my duties as
- US ambassador to Macedonia, that I would take on the position as
- 24 special envoy to Kosovo.
- Q. And as special envoy to Kosovo, to whom did you report?

- 1 A. I reported to -- as special envoy to Kosovo, I reported to
- 2 Secretary of State Madeleine Albright. I should add, however, that
- by this time Holbrooke, former Assistant Secretary Holbrooke was very
- 4 much interested in the issue and frequently advised me on issues, and
- 5 I kept him informed.
- Q. Did you have an understanding that Secretary Albright was
- 7 relying on your assessments as the special envoy?
- 8 A. She relied on a lot of my assessments, but I think she also got
- 9 information from other people as well.
- 10 Q. What was your mandate as the special envoy for Kosovo?
- 11 A. Early on, it was understood that we should support a
- 12 political -- some kind of political solution, and to try to step away
- from the growing potential and -- the growing potential violence. So
- early on, I began to try to put together with colleagues in the
- 15 State Department an autonomy plan that would restore Kosovo's
- autonomy and give Kosovo its self-governance. So that was the idea
- to pursue with Kosovo and with Serbia.
- Q. Why was it important to try to achieve a political solution?
- 19 A. Well, I think it is always preferable to achieve a political
- solution rather than some other approach, but it was especially
- important here because our European partners and allies, a number of
- them were concerned about the outbreak of violence again on their
- continent and very much wanted to see a political solution achieved.
- And so for that reason, we worked very closely with the
- Europeans as we had in the lead up to the Dayton peace accords as

- well.
- Q. And in working with your European allies, was there something
- known as the Contact Group; and if so, could you explain what it was?
- 4 A. Excuse me. I'm trying to wait this five seconds, but I can see
- 5 I'm not doing a good job of that.
- The Contact Group was a kind of coordinating mechanism which
- 7 involved the interests of Russia, the United States, and the
- 8 Europeans. And so it did not include all of the European states that
- 9 had a particular interest in it. It included Germany, it included
- 10 France, it included the UK, and later on began to include Italy
- because of Italy's great interest in the Balkans, which are very
- close to Italy. So it also included a representative from Russia
- and, of course, the US.
- 14 The Contact Group was at several levels. There was my level as
- a negotiator, but there were also -- the ministers would get together
- on the basis of being in the Contact Group and discuss the way
- 17 forward on Kosovo.
- 18 Q. Thank you. In terms of your preparing for your work as special
- envoy, did your daily routine include reading press reports from the
- 20 region or about the region?
- 21 A. Yes. My daily routine included reading press reports and also
- coordinating with interested parties, which included, of course, a
- number of European states beyond just the Contact Group.
- Q. Did you read cables, US diplomatic cables?
- 25 A. Yes. Yes, I read cables and I wrote some myself.

- 1 Q. Do you recall from which posts the cables were written?
- 2 A. They were written from a number of different posts. You might
- have a cable written from a European country because the ambassador
- 4 there had had a discussion and the issue of Kosovo had come up, and
- so the embassy in a given European post might send in a cable on it.
- 6 Cables in the -- were quite numerous and, to be diplomatic about
- 7 it, some were more useful than others.
- 8 Q. Did you read intelligence reports regularly?
- 9 A. As part of my duties, yes.
- 10 Q. Was it raw intelligence or was it reviewed?
- 11 A. Well, I would say it was both.
- Q. Would you get briefings from embassy staff?
- 13 A. Yes.
- 14 Q. And would that include the Belgrade embassy?
- 15 A. Yes, it did include the Belgrade embassy, but the -- by the time
- I was there, the person on the ground was myself, and then, of
- course, they created -- we created, actually, this monitoring
- 18 organisation.
- 19 Q. Would you receive information from other parts of the
- State Department and the National Security Council on the issue of
- 21 Kosovo?
- 22 A. Yes. Kosovo was a primary issue. So if the secretary, for
- example, hosted a foreign minister from a European country, chances
- were very high that one of the first discussion points would be about
- Kosovo. So someone on the secretary's staff would make sure that I

knew that she had had a conversation with somebody about Kosovo.

- The secretary, of course, is always prepared with a number of
- 3 talking points. Some of those issues, they could range all over the
- 4 waterfront of US-European relations, for example, but in those days
- 5 Kosovo would likely be one of the issues. And at least with respect
- to Kosovo, people would make sure I knew what the secretary had said
- or what she had heard from some foreign diplomat.
- 8 Q. As part of your mandate to find a political solution, did you
- 9 try to identify points of contact and authority on both the Serb side
- 10 and the Kosova side?
- 11 A. Yes, I did. It was very important to talk to various parties
- who were going to be either part of the solution or part of the
- problem. And so, yes, I did. I spent a lot of time trying to deal
- with people both from Kosovo and from Serbia.
- Q. And on the Serb side, who did you work with?
- 16 A. On the Serb side, I worked primarily with President Milosevic
- and his team. That included his former foreign minister, then
- prime minister at one point, Milutinovic. But basically, on the Serb
- 19 side, it was very limited and it was mainly Milosevic.
- Q. And on the Kosovo Albanian side, did you find anyone who could
- speak with authority on behalf of Kosovo Albanians?
- 22 A. That was a very challenging and, at times, vexsome operation of
- trying to find people who could speak with authority. Everyone had
- an opinion about it. It was never a problem to find someone with an
- opinion. It was a problem to find someone with authority.

One of the people was, of course, the head of the League of

- Democrats of Kosovo, the LDK, and that was Ibrahim Rugova. He had
- been at it for -- he had had a leadership position in Kosovo, albeit
- 4 informal leadership position, for well over a decade. As I mentioned
- to you, I first met him in 1989 at Ambassador Zimmerman's home, and
- 6 he was already well-established as a Kosovo leader. But unlike in
- 7 Serbia, President Rugova was not the only person that one could talk
- 8 to in Kosovo, because he did not represent the range of views.
- 9 Q. Can you describe the difference in 1998 between your engagement
- with the Serbian side and with the Kosovars in terms of organisation,
- 11 structure, line of authority, and decision-making.
- 12 A. Let me be sure I understand the question. You want to know
- lines of authority and decision-making within Serbia and lines of
- authority and decision-making within Kosovo, or among the Kosovo
- 15 Albanians?
- 16 Q. Yes, and what the differences were, if any.
- 17 A. Well, in Serbia, I don't mean to be facetious and call it
- one-stop shopping, but one could get a lot of information and a lot
- 19 of clarity in a conversation with President Milosevic. This
- situation was not mirrored in Kosovo. In Kosovo, these were
- 21 discussions I had with President Rugova, but it was not sufficient to
- get a broad enough understanding of the Kosovo position, nor was
- 23 president -- I call him president because Rugova had a title as head
- of the LDK, president of the LDK. But nor if I talked to him could I
- count on something being implemented, so we needed to go further.

- 1 Q. You mentioned that Ambassador Holbrooke had an interest in this
- issue. Can you tell us what Ambassador Holbrooke's role was in this
- 3 period?

- 5 historic contribution to peace and security in the Balkans in Dayton,
- 6 felt a certain frustration that Dayton was -- that there were
- 7 continued serious problems in the Balkans, and that because he had
- 8 been so focused on Bosnia at Dayton, which was the purpose of Dayton,
- 9 he felt that he needed to somehow be engaged and help get Kosovo to a
- 10 better -- to a solution.
- And so he gave me a lot of advice on what to do in Kosovo, some
- of which I asked for, some of which I did not ask for. And he also
- gave advice to Secretary Albright, and I think the same goes for her,
- some of the advice she wanted to get from him and some she didn't.
- 15 Ambassador Holbrooke was extremely active personage who had many
- opinions and many of them were very valid opinions, and so one would
- pay attention to what he had to say.
- 18 Q. Was there ever a time when the United States encouraged
- 19 Mr. Rugova to meet with Mr. Milosevic; and if so, why?
- 20 A. Yes. This was the first time that Ambassador Holbrooke went to
- 21 Prishtine. I went with him. And we sat down with President Rugova.
- 22 And while we hadn't really discussed this in advance,
- 23 Ambassador Holbrooke thought it would be a good idea if Rugova met
- with Milosevic in Belgrade because he hoped that this meeting could
- solve a lot of problems. I must say, I was more sceptical.

- was not making any progress.
- Q. Do you know who may have been leading any opposition to him
- 3 within Prishtine?
- 4 A. I'm not in a real position to say who, but I can tell you that
- 5 people that we often met with had great frustrations with Rugova and
- 6 the LDK structures. Some of those people joined us at the
- 7 Rambouillet conference the following year. So Mr. Rugova, I think,
- was having a difficult time projecting leadership and any sense of
- 9 accomplishment in dealing with Serbia. And I want to stress the
- context of this was that somehow Bosnia had a way forward thanks to
- 11 Dayton and Kosovo was still stuck.
- Q. Did you have any opportunity to discuss with intellectuals such
- as Veton Surroi and Rexhep Qosja what their views were of Mr. Rugova?
- 14 A. Yes, I did. And I think it's fair to say there was a lot of
- scepticism about his ability to accomplish any -- to make any
- progress. The immediate issue for Kosovo was to try to create a
- separate republic. The Serbs did not agree to that because they saw

2 A. Yes. And that was part of a sequence of events that brought the

issues in Kosovo to a kind of crisis level. Ambassador Gelbard, as

4 many Foreign Service officers do, drew heavily on past experiences.

5 His past experiences had been in Latin America where he dealt with

6 narcotics trade and other issues involving organised crime. At one

7 point, he made a statement to the effect that he has dealt with

8 various organised criminals, and he used the term "terrorists," and

9 that he viewed the KLA as terrorists. It was a press -- it was a

10 comment he made to the press, and it was soon followed by an incident

in which Serbian security forces surrounded the home of the Jashari

family with the consequence that everyone was killed in this. It was

a major, major outbreak of hostilities.

There was a lot of criticism that Gelbard's statement that the

KLA were terrorists had somehow precipitated this particular incident

on the part of the Serbian security forces, that they had felt that

Gelbard had somehow signalled a green light for this. I

parenthetically would add that I don't think there is any evidence

for that. But this was certainly what was being discussed, that if

the American envoy calls the KLA terrorists, then somehow it's a

21 signal to the Serbs to move against them.

Gelbard then took a very tough view on the Serbs for doing this,

for engaging in this attack on these people, and it also included a

very tough conversation with -- that Gelbard had with Milosevic, with

the consequence that Milosevic said he would not see Gelbard anymore.

So the whole issue in May was started by Gelbard speaking about

- 2 his prior knowledge of criminals and terrorists from Latin America,

- 5 Milosevic refusing to see Gelbard anymore. So it really took an
- issue that was serious and made it even more serious and more deadly.
- 7 Q. Just as a background question: Does the United States have a
- 8 formal process for designating foreign terrorist organisations?
- 9 A. The US does have a formal process of designating terrorist
- organisations, and, to my recollection, that was not ever done with
- 11 respect to the KLA.
- 12 Q. Thank you. When did you first make contact with the KLA?
- 13 A. The issue for me in the summer of 1998, working with my staff
- and with others, was to find a KLA official or group of officials who
- could really speak for the KLA. I might add that I worked on this

1 Q. Understood. You continue then in this interview:

- 5 Do you recall Mehmet Hajrizi denouncing Rugova in this meeting?
- A. Again, I think there was a lot of frustration with the LDK's
- 7 monopoly on the Kosovo Albanian view, and that was reflected in
- 8 this -- I don't want to call it a so-called government because it
- 9 meant a lot to people, but it was a government that people not in the
- 10 LDK did not feel that it represented their views. So these people

United States and other members of the Contact Group were proposing?

- 2 A. It involved establishing full autonomy for Kosovo, and
- 3 ultimately the Rambouillet Accords included the idea of a referendum
- on its eventual disposition. And importantly, it laid out the idea
- that NATO would provide security for Kosovo, no longer any Serbian
- 6 police or military units. It also -- an underlying principle was the
- idea to try to push things down to be as local as possible, because
- 8 that was certainly our sense of how Kosovo was run. But it was also
- 9 a way to protect the Serb communities, because there was an
- understanding that if this became a Kosovo state, that the Serb
- 11 communities would want to leave.
- 12 Q. Now, during the negotiations, did there come a time when the
- United States asked Mr. Thaci to accept the proposal on the table?

- 9 addressed the Kosovo delegation, and he came up with a very good
- proposal which he then brought to the assembled foreign ministers,
