19	First, some general observations. I remind the parties to
20	comply with the instructions in the Order on the Conduct of the
21	Proceedings. In addition, the parties are informed that during the
22	presentation of evidence, parties are expected to use the
23	presentation queue tool in Legal Workflow when questioning witnesses,
24	as described in the Order on the Conduct of the Proceedings and the
25	Panel's order of April 5th, 2023.

unless the Panel orders otherwise.

When referring to any material during questioning of a witness, the examining party shall identify such material by reference to the relevant exhibit number if already admitted or an ERN, and shall also indicate the corresponding page reference in Albanian or English, depending on the language of the particular material.

8 The parties and participants, with the assistance of CMU, should 9 keep track of the time used in questioning a witness in this regard. 10 The Panel notes that a party's time in redirect will be counted 11 toward their overall time.

Finally, I note that on a number of occasions redactions to the 12 record have been required already. This is not acceptable. The 13 14 Panel should not be consistently put in the position of having to authorise redactions to the record. The Panel reminds the parties 15 and the participants of their duty to observe, at all times 16 throughout the presentation of evidence, all protective measures in 17 place. In particular, the parties and participants shall exclusively 18 refer to protected witnesses by their pseudonyms; refrain from 19 mentioning in public session any information which could lead to the 20 21 identification of protected witnesses, victims, or their relatives; be mindful at all times of the way in which questions are asked of 22 the witness so that no information subject to protective measures is 23 disclosed; and use gender-neutral language. 24

In addition, the Panel notes that the list of SPO witnesses is

currently classified as confidential. Therefore, the fact that an individual is a prospective SPO witness is confidential, even when such an individual is not a protected witness. Finally, if ever counsel feels that it is absolutely necessary

to refer to confidential information, please ask to go into private
session.

7 We note or we were advised, Mr. Emmerson, that the Veseli 8 Defence wishes to issue a matter in private session, and we've been 9 advised what that is about. And we would suggest that an objection 10 to a question needs to be addressed at the time of the issuance of 11 the question, and if private session is necessary, we will honour 12 that. And we will be aware of the fact that you have an objection to 13 issue.

14 Anything else to take up at this time?

15 Mr. Misetic.

MR. MISETIC: Good morning, Mr. President. Just to introduce someone who hasn't been with us thus far. To my right is our legal associate Ms. Fellenza Limani. Thank you.

19 PRESIDING JUDGE SMITH: Thank you very much, Mr. Misetic.

20 Anything else from anybody else before we begin?

21 MR. HALLING: Yes, Your Honour. We have two short matters, and 22 actually an additional appearance as well. Earl Sulivan appearing 23 with the SPO today.

The first is just actually a correction for the record. For the preparation note, this is 112720, 112723, the witness's changes in

the Albanian transcript are all recorded accurately, but the English 1 analogues that we added turns out need minor adjustments. 2 So just quickly for the record, paragraph 6 of the preparation 3 note should read page 14, not 10, for the English transcript; the 4 second ERN in paragraph 8 should be ET, not AT; and the first ERN in 5 paragraph 9 should be ET, not AT. 6 As for the request, on Thursday we forwarded a request from the 7 witness to have certain notes available as a hard-copy reference 8 during their testimony, and we would request a ruling on that before 9 10 the witness is brought in. PRESIDING JUDGE SMITH: Wish to be heard, anybody, on that 11 request? 12 The notes are okay. No problem with them. 13 MR. HALLING: So that would be -- we have the two sets of 14 documents, the two sets of notes in this binder here. We can take 15 out the witness's own notes because that was an alternative request. 16 PRESIDING JUDGE SMITH: Yes, we don't want the witness's own 17 notes, have the actual notes, and I will instruct her on that when 18 she comes in the room. 19 Go ahead, Mr. Misetic. 20 MR. MISETIC: Mr. President, I apologise, I did not hear you ask 21 for our opinions on the notes. We did have an objection to the 22

notes. We don't want to set a precedent here, and we believe it's not consistent with the Order on the Conduct of Proceedings.
Paragraph 120 of the Order of Conduct of Proceedings talks about use

of prior statements. We think notes are analogous to prior 1 statements. And they can be used to refresh the memory only where 2 it's been shown that the witness needs refreshing of the memory. And 3 on that basis, unless there is an explanation or a basis that's being 4 put forward as to why this particular witness needs notes or witness 5 statements, et cetera, to accompany her in her testimony, we would 6 say that we would like to stick with the rule as drafted and then not 7 deviate from that absence I'm showing that there is a need for it. 8 PRESIDING JUDGE SMITH: When she asks the Court if she has 9 10 permission to refer to her notes, that will be granted to her. MR. MISETIC: If that's the case, then, yes, but we would 11 12 actually like to see if she has an independent recollection of something. 13 14 PRESIDING JUDGE SMITH: She can stop. She can stop. She doesn't have to use that term. If she says, "I need to look at my 15 notes," I can understand that. 16 MR. MISETIC: Okay. But just as long as she's not, you know --17 PRESIDING JUDGE SMITH: I understand. 18 MR. MISETIC: -- reading. Thank you. 19 PRESIDING JUDGE SMITH: Your witnesses will be granted the same 20 21 opportunity. I can assure you of that. MR. HALLING: Thank you, Your Honour. I don't know if the 22 Defence wants to inspect the binder as it is, but we're available to 23 give it to the Court Usher [Overlapping speakers] ... 24 PRESIDING JUDGE SMITH: I will leave that between the Defence 25
