The Defence has objected to its admission on the grounds that it lacks adequate foundation. 2

It was marked as Exhibit P104 MFI. 3

Having considered the parties' submissions, the Panel makes the 4 following ruling. The proposed document is clearly relevant. In 5 particular, in respect of the reasons that might have resulted in the 6 detention of certain individuals listed in this document and who are 7 alleged victims of crimes alleged in the present case. 8

The Panel is satisfied that the document is prima facie 9 authentic and probative, and that it appears from the covering page 10 that it was seized by UNMIK international police from the K-SHIK 11 12 headquarters.

The Panel further notes that the Panel has already heard or 13 14 received evidence in respect of at least four of the listed victims, which corroborates to some extent the content and reliability of this 15 document. 16

There is no indication that the probative value of this document 17 is outweighed by any prejudice to the defendants, which will be able 18 to question the present witness and others in respect to the content 19 of this document. 20

The Panel is, therefore, satisfied that the requirements of 21 Rule 138(1) are met and, therefore, admits this document as 22 Exhibit P104. 23
