and Armed Forces of the Republic of Kosovo, FARK. 1 FARK and certain other units and officers in and around the 2 Dukagjini operational zone only respected the ultimate authority of 3 the Government of the Republic of Kosovo, also known as the 4 government-in-exile. 5 At meetings between FARK and KLA members around late August 1998 6 and early September 1998, KLA General Staff members, including 7 Hashim Thaci, Rexhep Selimi, Bislim Zyrapi, and Lahi Brahimaj, 8 asserted the authority of the KLA General Staff over forces in the 9 Dukagjini operational zone. 10 According to the witness, Thaci appeared to be the most senior 11 KLA official at certain of these meetings. 12 The witness also provides information about the structure and 13 organisation of certain KLA and FARK units based in Albania in late 14 1998 and 1999. Around March 1999, the witness found a document 15 purportedly from Azem Syla and Jakup Krasniqi at a certain KLA base 16 in Albania. The document asserted the exclusive authority of the KLA 17 18 General Staff and denied the authority of the government-in-exile. The witness provides information about the KLA's treatment of 19 certain perceived opponents, including FARK members and alleged 20 collaborators, in the Dukagjini operational zone and locations in 21 Albania. 22 Witness, two of your prior statements have now been admitted and Q. 23 cover your experiences and knowledge of relevant events in great 24
