22	written submissions on 13 October 2023 in filings F01855 and F01856,
23	respectively. The Panel observes that the admission of some of these
24	items is unopposed by the SPO. These comprise two SPO official
25	notes, a news article, and an extract from a LinkedIn and video

excerpt. These items have been put to the Witness W03880 during his
testimony on 9 and 10 October 2023.

With respect to these items, the Panel is satisfied that the requirements of Rule 138(1) are met. Therefore, pursuant to Article 40(6)(h) of the Law and Rule 138(1) of the Rules the following items are admitted and shall be assigned an exhibit number: 112748 to 112750 RED together with its Albanian translation RED; 114682 to 114683 RED; DHT02667 to DHT02671; DHT02675 to DHT02681; DHT02682 to DHT02682-01, together with the transcripts TR and TR-ET.

10 The Thaci Defence also seeks admission of the following four 11 items: DHT02025 to DHT02029; DHT02030 to DHT02043, together with the 12 English translation ET; DHT02044 to DHT02047; and DHT02683 to 13 DHT02684. These items have been put to Witness 3380 during his 14 testimony on 9 October 2023.

15 The

The SPO opposes their admission.

With respect to the first item, the Panel observes that this 16 item consists of a witness statement of an individual other than 17 18 W03880, which is being offered for the truth of its content and which was given in the context of or in connection with legal proceedings. 19 As previously ruled by the Panel, such statements are subject to 20 Rules 153 and 155. If the Defence wishes to tender it, it will, 21 therefore, have to do so in accordance with those rules. Therefore, 22 item DHT02025 to DHT02029 are not admitted. 23

With respect to the remaining three items, the Panel is satisfied that they are relevant. In particular, in respect of the

status of W03880 and/or W04828 at different points in time under the relevant provisions of international humanitarian law. Furthermore, the Panel considers that the three items bear sufficient formal indication of their origin and is satisfied of their *prima facie* authenticity. The Panel notes, however, that the witness was not in a position to comment upon their origin, the process by which they were prepared, or the truth or otherwise of their content.

8 The Panel is also satisfied that these three items have 9 prima facie probative value which is not outweighed by their 10 prejudicial effect. The effect to which the witness was able to 11 authenticate these documents, meaningfully comment on their content, 12 or confirm the truth or accuracy thereof will be taken into account 13 when deciding upon the weight and probative value to be attached to 14 them.

In light of the foregoing, the Panel is satisfied that the requirements of Rule 138(1) are met. Therefore, pursuant to Article 40(6)(h) of the Law and Rule 138(1) of the Rules, the following items are admitted and shall be assigned an exhibit number: DHT02030 to DHT02043, together with the English translation ET; DHT02044 to DHT02047; and DHT02683 to DHT02684.
