5 PRESIDING JUDGE SMITH: Madam Court Officer, you may call the
6 case.

7 THE COURT OFFICER: Good morning, Your Honour. This is case
8 KSC-BC-2020-06, The Specialist Prosecutor versus Hashim Thaci,
9 Kadri Veseli, Rexhep Selimi, and Jakup Krasniqi.

10 PRESIDING JUDGE SMITH: Thank you. And good morning.

11 I note for the record that the accused are present in court.

12 As you are all aware, today we will start hearing the testimony
13 of Prosecution Witness W04739. Tomorrow, we will resume W04147's
14 testimony.

15 Before we start, there are some preliminary matters to deal
16 with.

17 First, regarding the examination time for W04739, I remind you
18 that it would be best if we could complete this witness's testimony
19 by the end of Thursday, as we then have a two-week break. The Panel
20 also indicated last week that we considered the cross-examine
21 estimates to be somewhat excessive, and I hope you can continue to
22 keep that in mind as you go through the cross-examination and the
23 direct examination.

24 Next, the Panel will now rule on the admission of audio-visual
25 recordings of admitted Rule 153 statements.

1 The Panel notes that, pursuant to the Panel's fourth oral order
2 of 15 January 2024, in filing F02197, the SPO has tendered the
3 audio-visual recordings of witness statements previously admitted
4 pursuant to 153 in the Panel's decision F01904 and F02111.

5 Having found in those decisions that the relevant Rule 153
6 statements are admissible pursuant to Rules 138(1) and 153, the Panel
7 admits into evidence the corresponding audio-visual recordings of
8 those statements as identified in Annex 1 to filing F02197, and
9 directs the Registry to assign the admitted audio-visual recordings
10 the same exhibit numbers which have been assigned to the relevant
11 Rule 153 statements as indicated in Annex 1 to filing F02197.

12 The Panel further directs the SPO to make submissions on the
13 classification of the admitted audio-video recordings by no later
14 than 5 April -- Friday, April 5, 2024.

15 This concludes the oral order.

16 Lastly, I recall that for this witness testimony is in closed
17 session, which was ordered for the protection of the witness. So
18 unless there are any other preliminary matters that the parties or
19 participants wish to raise, we will now move into closed session.

20 MR. HALLING: Not a preliminary matter as such, but just a new
21 appearance for the record. In the back of the courtroom is new
22 SPO Prosecutor, John Capin.

23 Thank you.

24 PRESIDING JUDGE SMITH: Thank you.

25 So, Madam Court Officer, please bring us into closed session.
