DEVANEY: Good morning, Your Honour. Unfortunately, we do not have that information right now. We will check and revert as 8 soon as possible. 9 PRESIDING JUDGE SMITH: All right. At the break perhaps --10 MR. First, the Panel considers that the documents are relevant to the charges in the indictment. They pertain to the alleged detention of individuals by KLA members and refer to the involvement of certain KLA members in that context.

The Panel is also of the view that the documents are prima facie authentic and reliable. The documents bear sufficient indicia of authenticity, indicate their source, and are formatted consistently with documents of a similar nature admitted by the Panel in the past. While they were not shown directly to the witness, their content and

by the parties.

Finally, the Panel is also satisfied that the documents have 4 probative value which is not is outweighed by any prejudice. In 5 particular, the Panel considers that the documents could not be shown 6 7 in court only because further clearance from their author was required; the documents and their content are closely connected to 8 questions asked by the Defence to the relevant witness in these 9 proceedings; and, three, their content does not go beyond the scope 10 11 of matters already on the record. Therefore, the Panel considers 12 that in light of the specific circumstances as outlined above, no prejudice would derive from admitting the documents. However, the 13 14 extent to which any of the documents or their contents were put to the relevant witness might be relevant to the weight that this Panel 15 is prepared to give to these documents. 16

For these reasons, the Panel finds that 1D00258 MFI and 1D00259 MFI meet the requirements of Rule 138(1) and admits them into evidence.

20 This concludes the Panel's second order.
