The Panel is of the view that the Defence has demonstrated good cause for an extension of time given the volume of material involved, the importance of the issues of concern to the particular filing and competing deadlines in relation to trial preparation activities.

7 The Panel further finds that granting a short extension of time 8 to the Defence to file its response would not prejudice the other 9 parties and participants and would not unduly delay the proceedings.

However, the Panel considers that the extension of time sought by the Defence until 27 October 2023 is excessive and would unduly delay the resolution of this matter. Therefore, pursuant to Article 40(2) of the Law and Rule 9(5)(a) of the Rules, the Panel will extend the deadline for the Defence teams to respond to the SPO motion F01804 to Tuesday, 17 October 2023.

16 The Panel also grants *proprio motu* an extension of time for the 17 SPO to file any reply until Tuesday, 31 October 2023.
