On 27 August 2023, the Panel heard further submissions on the 1 same issue.

The Panel recalls that pursuant to paragraph 83 of the Order on Conduct of the Proceedings, a presentation queue listing all documents or other material to be used by the cross-examining party must be released to the Trial Panel and other parties and participants immediately upon the completion of the direct examination of that witness at the latest.

On 13 April 2023, the Panel, upon the parties' suggestion, amended this paragraph by ordering the parties and participants to only upload material additional to the calling party's list to their presentation queues. This amendment was sought and granted only insofar as it dispensed the cross-examining party from having to place on its presentation queue documents and exhibits that already appear on the presentation queue of the calling party.

The amendment was not intended to dispense with the need for each cross-examining party to identify, in its own queue, what documents and exhibits it plans to use for its cross-examination of a witness.

The Panel, therefore, clarifies that the amendment to the Order on Conduct of Proceedings only dispensed with the requirement for the parties and participants to upload material from the calling party's presentation queue. This means that if an item is not on the calling party's presentation queue, and a cross-examining party intends to use it for cross-examination, it must include it on its presentation

queue irrespective of whether it also appears on the presentation

queue of the other cross-examining parties.

Therefore, in the current circumstance, each Defence team shall

between the presentation queues of the Defence teams, the Panel
considers it will best serve the need to have a clear notice of the
nature and scope of the intended cross-examination by each Defence

The Panel notes, however, that the absence of a document from a presentation queue of a cross-examining party will not, in principle, prevent it from cross-examining a witness in relation to such a document. Where a cross-examining party has formed the view that it should ask a question in relation to an item not yet appearing on its presentation queue, it shall give prompt notice via e-mail or other means to the other parties or participants of its intention to use such an item and amend its presentation queue accordingly.

Any objection based on the belatedness or unfairness of last-minute notice of that sort will be addressed by the Panel if and when such instances arise.

The Panel reiterates the principle stated in paragraph 83 of its Order on the Conduct of Proceedings; namely, that notice of documents or other materials to be used in cross-examination shall, in
